## 5. **County Councillors Report**

District ClIr Blake gave a report on behalf of County ClIr Blake. He said that Bucks County Council has a shortfall of £53m over the next 3 years but the transitional funding has been secured. Changes to the highways maintenance crews are being made and work will be programmed on a priority basis. All reported potholes will be assessed but only category 1 or 2 potholes will be repaired during the coming year. Unitary status is being considered and it is hoped that this will take place sometime in the near future.

#### 6. **District Councillors Report**

District ClIr Blake gave a report. He said that AVDC are continuing to make savings by creating a new organisational structure. 117 delegates attended a conference to see how AVDC have achieved their services. AVDC are now offering their services to other authorities. AVDC is now using Amazon cloud to store data, the first authority to use this route. Many services can be accessed online. The Vale of Aylesbury lottery is working well and £0.50 out of every £1 goes to a good cause. The new Travel Lodge and University have been built. Aylesbury Vale broadband was set up last year and a pilot project undertaken. The ducting for broadband has been finished from North Marston to Granborough and will carry on to Swanborne shortly. Two new companies have been formed, Limecart and Inkgen, which provide services to residents and businesses. AVDC's long term plan is to axe council tax. The community chest will come to an end this year. It was set up 9 years ago with £5m and £4.5m has gone to good causes.
